Data protection according to § EU Data Protection Regulation (DSGVO) valid from 25 May 2018

We collect and use your personal data exclusively within the framework of the provisions of the Data Protection Act of the Federal Republic of Germany (BDSG). For this purpose, we inform you about the type, scope and purpose of the collection and use of personal data.

Our company is committed to protecting the personal information you provide to us. We are aware of its importance when we use it.

With the following information, we would like to give you an overview of the processing of your personal data by us and your rights under data protection law. Which data is processed in detail and how it is used depends largely on the requested or agreed services.

Processing of your personal data

When you register on our website, we collect your personal data (e-mail address, name, address, telephone number, account details if applicable) in order to set up a customer account for you, where you can view data about your completed, open or recently shipped orders and manage your address and account details. If you send us a job application, your CV will be stored.

We use the personal data you provide primarily to answer your inquiries, process your orders or provide you with access to specific information or offers. If necessary, the data is transferred to service companies for business processing. For example, the service providers used for order processing (carriers, logistics companies) receive the necessary data for order and order processing. The service providers used may only use the data for the fulfilment of their order. In order to be able to communicate with you (for example, to confirm the receipt of your order), we need your e-mail address; we also use this for your identification in the customer login area. We store your IP address, which is transmitted to us

during your purchase, for a limited period of time in order to be able to protect ourselves against misuse.

In order to maintain customer relationships, we or a service provider we engage may need to use this personal information to contact you about service offerings that may be useful to your business or to conduct online surveys to better understand our customers' needs.

By order of the competent authorities, we may in individual cases provide information on data stored about you, insofar as this is necessary for the purposes of criminal prosecution, to avert danger, to fulfil the statutory duties of the authorities or to enforce intellectual property rights.

We also use your data to inform you about certain products, services or marketing campaigns that may be of interest to you. Secure data transmission

Your personal data is transmitted securely by us through encryption. This applies to your order and also to the customer login. We use the coding system SSL (Secure Socket Layer). It is true that no one can guarantee absolute protection. However, we secure our website and other systems by technical and organizational measures against loss, destruction, access, modification or distribution of your data by unauthorized persons.

We cannot guarantee the absolute security of your personal data transmitted via our website or by e-mail. Any transmission is at your own risk. Some of the information you provide to us may be sensitive personal data as defined under the Data Protection Act 1998. We advise users of this website to send such information via a secure system. The sensitive personal data will only be processed by us after you have placed your order.

Credit check

Under certain conditions, you have the option with us to pay conveniently by invoice or direct debit. If you choose one of these payment methods during the ordering process, we must protect you and ourselves from misuse. Therefore, we carry out a credit check for these payment methods and transmit the personal data required for this purpose (first name and surname, address data, date of birth) to SCHUFA AG, Kormoranweg 5, 65201 Wiesbaden, Germany, which carries out a corresponding evaluation on the basis of mathematical-statistical procedures. Your address data are also included in the calculation of the probability value. We use the information received about the statistical probability of a payment default ("probability value") for a weighed decision as to whether a payment by invoice or direct debit can actually be offered to you. If this is not possible, you can only pay by prepayment, credit card or PayPal.

You can object to the transfer of your data to SCHUFA AG at any time. A notification in text form (e.g. e-mail, fax, letter) is sufficient for this. However, we would like to point out that in this case only the payment methods prepayment, credit card or PayPal will be available to you.

Data transmission and logging for internal system and statistical purposes

For technical reasons, your web browser automatically transmits data to our web server when you access our website. This data includes the date and time of access, URL of the referring website, retrieved file, amount of data sent, browser type and version, operating system and your IP address. This data is stored separately from other data that you enter when using our offer. It is not possible for us to assign this data to a specific person. This data is only evaluated for statistical purposes or in the context of law enforcement.

Special data protection information on cookies from third-party providers

We use cookies on the website.

Cookies are small text files that can be placed on the hard drive of the visitor to a website and that store information about the visit to a website in order to identify repeated visits. Among other things, they are used to facilitate navigation on a website or to control the display of advertisements. In addition, the data obtained with the cookie is used to create statistics about the pages. However, this data is anonymous and is not associated with personal data.

The cookie, which is primarily used by us on both websites, is exclusively used for the functionality of the user account and that of the shopping basket, so that this is also retained between visits to our homepage.

For the extension and improvement of our internet offer, cookies could be set for the function Google Analytics, Matomo and, if you have reached the www.test-tape.com website via Google AdWords, a cookie for Google AdWords.

All cookie functions can be deactivated by you at any time via the settings of your web browser and cookies that have already been created can be deleted completely. For more details, please refer to the help function of your web browser. Please note, however, that cookies are necessary for some functions on our homepage (e.g. the shopping cart) and deactivating them can lead to malfunctions.
